AN ORDINANCE AMENDING THE BOROUGH CODE OF THE BOROUGH OF GARWOOD BY AMENDING CHAPTER 21, ENTITLED "VEHICLES AND TRAFFIC", ARTICLE I "TRAFFIC AND PARKING", SECTIONS 21-7 "ONE-HOUR PARKING 7:00 AM TO 7:00 PM" AND 21-8 "TWO-HOUR PARKING".

WHEREAS, the Borough of Garwood (the "Borough") has previously adopted Chapter 21 of the Code of the Borough of Garwood which established and governs restrictions and regulations on parking and traffic in the Borough; and

WHEREAS, the Borough is seeking to amend Section 21-7 "One-hour parking 7:00 a.m. to 7:00 p.m." and Section 21-8 "Two-hour Parking" to comply with the new paid parking zones set forth in Section 21-8.8; and

WHEREAS, the Borough Council has determined it appropriate to amend said Code;

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Garwood that Chapter 21 of the Borough Code of the Borough of Garwood entitled, "Vehicles and Traffic", Article I "Traffic and Parking", Sections 21-7 "One-hour parking 7:00 a.m. to 7:00 p.m." and 21-8 "Two-hour Parking" is hereby amended as follows (additions underscored, deletions struck-through):

§ 21-7 One-hour parking 7:00 a.m. to 7:00 p.m.

A. No person shall park a motor vehicle or any other vehicle continuously on the following highways and areas for more than one hour duration between the hours of 7:00 a.m. and 7:00 p.m. Monday through Saturday:

~~Center Street Both From North Avenue to 100 feet south of Willow Avenue~~

Chestnut Street Both From North Avenue to the Westfield town line

North Avenue North From a point 178 feet east of the easterly side line of Oak Street to the Cranford town line (N.J. Rt. 28)

North Avenue South From the easterly side line of Oak Street to the Cranford town line (N.J. Rt. 28)

Second Avenue South From Walnut Street to a point ending 310 feet west of the westerly curb of Walnut Street

South Avenue Both From the Westfield line to ~~the Cranford line~~ West Street and East Street to the Cranford line

Walnut Street East From a point 87 feet north of North Avenue to a point 107 feet north of North Avenue

Name of Street Side Location

Walnut Street East From a point 53 feet south of Second Avenue to a point 136 feet south of Second Avenue

B. One-hour parking 7:00 a.m. to 7:00 p.m. Sunday.

South Avenue North From a point 500 feet west of Center Street to a point 700 feet west of Center Street

§ 21-8 Two-hour parking.

A. No person shall park any vehicle on the following streets for more than two hours duration between the hours of 7:00 a.m. and 7:00 p.m.:

Beech Avenue North 352 feet west of East Street

Locust Avenue South 352 feet west of East Street

Maple Street East From North Avenue to a point ending 88 feet north of the northerly curb of Second Avenue

Maple Street West From North Avenue to a point ending 162 feet north of the extended northerly curblines of Second Avenue

North Avenue (N.J. Rt. 28) Both From the Westfield town line to the easterly side line of Oak Street (extended)

~~West Street West From South Avenue to Willow Avenue~~

Willow Avenue North From easterly curblines of Center Street to a point 80 feet west of Center Street

Winslow Place West 100 feet from the corner of North Avenue

B. No person shall park any vehicle, other than one displaying a residential parking permit issued in accordance with § 21-31 et seq., on the following streets for more than two hours' duration between the hours of 10:00 a.m. and 2:00 p.m., Monday through Friday, holidays excluded:

Fourth Avenue	Both	Between Walnut Street and Maple Street
Myrtle Avenue	Both	Between West Street and Oak Street
North Maple Street	Both	Between North Avenue and Fourth Avenue
North Oak Street	Both	Between Fourth Avenue and Fifth Avenue
North Oak Street	Both	Between North Avenue and Fourth Avenue
Second Avenue	Both	Between the Cranford border and North Maple Street
South Oak Street	Both	Between South Avenue and Spruce Avenue
Spruce Avenue	Both	Between East Street and Maple Street
Third Avenue	Both	Between the Cranford border and North Maple Street
Walnut Street	Both	Between Second Avenue and Fourth Avenue
West Street	Both	Between <u>Willow Avenue</u> South Avenue and Spruce Avenue
Willow Avenue	Both	Between West Street and Oak Street
Winslow Place	Both	Between North Avenue and Second Avenue

C. No person shall park any vehicle on the following streets for more than two hours duration at any time:

Name of Street	Side Location
Chestnut Street	East From a point 50 feet north of North Avenue approximately 415 feet north to the Westfield line, except where parking is prohibited under § 21-1
Chestnut Street	West From a point 75 feet north of North Avenue approximately 310 feet north to the Westfield line, except where parking is prohibited under § 21-1
Maple Street	West From a point 97 feet north of the northerly curblineline of North Avenue to a point 208 feet north thereof
Oak Street	East From a point beginning at the northeast corner of Oak Street and North Avenue, to a point 172.5 feet north thereof

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
