AN ORDINANCE AMENDING THE BOROUGH CODE OF THE BOROUGH OF GARWOOD BY AMENDING CHAPTER 21, ENTITLED “VEHICLES AND TRAFFIC”, ARTICLE I “TRAFFIC AND PARKING”, SECTION 21-4.2 “PARKING PROHIBITED BETWEEN 12:00 A.M. AND 11:59 P.M.”.

WHEREAS, the Borough of Garwood (the “Borough”) previously adopted Chapter 21 of the Code of the Borough of Garwood which established and governs restrictions and regulations on parking and traffic in the Borough; and

WHEREAS, the Borough is seeking to amend Section 21-4.2 prohibiting parking between 12:00 a.m. and 11:59 p.m.; and

WHEREAS, the Borough Council has determined it appropriate to amend said Ordinances; and

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Garwood that Chapter 21 of the Borough Code of the Borough of Garwood entitled, “Vehicles and Traffic”, Article I “Traffic and Parking”, Section 21-4.2 is hereby amended as follows (additions underscored, deletions ~~struck through~~):

§ 21-4.2 Parking prohibited between 12:00 a.m. and 11:59 p.m.

No person shall park any vehicle, other than one displaying a residential parking permit issued in accordance with § 21-31 et seq., on the following streets at any time between the hours of 12:00 a.m. and 11:59 p.m., Monday through Saturday, holidays excluded:

Maple Street	Both	Between South Avenue and Spruce Avenue
Myrtle Avenue	Both	Between East Street and Maple Street
West Street	<u>Westerly</u> Both	<u>Between Willow Avenue and Spruce Avenue</u> Between South Avenue and Spruce Avenue
<u>West Street</u>	<u>Easterly</u>	<u>Between Spruce Avenue and Myrtle Avenue</u>
Willow Avenue	Both	Between East Street and Maple Street

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
