AN ORDINANCE OF THE BOROUGH CODE OF THE BOROUGH OF GARWOOD BY AMENDING CHAPTER 21, ENTITLED “VEHICLES AND TRAFFIC”, ARTICLE I “TRAFFIC AND PARKING”, SECTION 21-1 “PARKING PROHIBITED”.

WHEREAS, the Borough of Garwood (the “Borough”) previously adopted Chapter 21 of the Code of the Borough of Garwood which established and governs restrictions and regulations on parking and traffic in the Borough; and

WHEREAS, the Borough is seeking to amend Section 21-1 “Prohibiting Parking” by removing certain prohibited parking in the Borough; and

WHEREAS, the Borough Council has determined it appropriate to amend said Ordinances; and

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Garwood that Chapter 21 of the Borough Code of the Borough of Garwood entitled, “Vehicles and Traffic”, Article I “Traffic and Parking”, Section 21-1 “Prohibited Parking” is hereby amended as follows (additions underscored, deletions ~~struck through~~):

§ 21-1 Parking prohibited.

No person shall park any vehicle upon any of the following streets or parts of streets at any time:

A. Center Street.

- (1) On the easterly side, northerly from the intersection of Myrtle Avenue for a distance of 65 feet.
- (2) On the westerly side from North Avenue to South Avenue.
- (3) On the easterly side from a point distant 89 feet northerly from the intersection of South Avenue northerly to North Avenue for a distance of 590 feet.
- (4) On the easterly side, southerly from the intersection of South Avenue for a distance of 71 feet.
- (5) On the westerly side, southerly from the intersection of South Avenue for a distance of 58 feet.

B. East Street.

- (1) On the easterly side from the southerly curblineline of Hickory Avenue to a point of 100 feet south thereof.
- (2) On the westerly side from the southerly curblineline of Hickory Avenue to a point of 100 feet south thereof.
- (3) On the westerly side from the southerly curblineline of Willow Avenue to a point 50 feet north thereof.
- (4) On the westerly side from the northerly curblineline of Willow Avenue to a point 50 feet north thereof.

- (5) On the easterly side from the southerly curblineline of Willow Avenue to appoint 50 feet south thereof.
 - (6) On the easterly side from the northerly curblineline of Willow Avenue to appoint of 50 feet north thereof.
 - (7) On the easterly side from the southerly curblineline of South Avenue to a point 148 feet south thereof.
- C. Fourth Avenue.
- (1) On the southerly side, westerly from the intersection of Walnut Street for a distance of 134 feet.
 - (2) On the southerly side, easterly from the intersection of Walnut Street for a distance of 175 feet.
- D. Center Street (former).
- (1) Easterly and westerly curbs of (former) Center Street between the southerly line of North Avenue and the northerly line of lands of the Central Railroad Company of New Jersey right-of-way.
- E. Lincoln Avenue.
- (1) Westerly side from the southerly curb of North Avenue to the Cranford-Garwood town line.
- F. Maple Street. [Amended 3-25-2008 by Ord. No. 08-06; 6-24-2008 by Ord. No. 08-11]
- (1) On the easterly side from the southerly curblineline of Second Avenue to a point 100 feet south thereof.
 - (2) On the westerly side between North Avenue and Second Avenue, for a distance of 20 feet on both sides of all driveways.
 - (3) On the westerly side from the northerly curblineline of North Avenue to a point 97 feet north thereof.
- G. Rankin Avenue.
- (1) On the northerly side of Rankin Avenue from Locust Avenue easterly to New Street.
- H. Second Avenue.
- (1) On the southerly side from a point distant 187 feet westerly from the intersection of Cedar Street for a distance of 126 feet.
 - (2) On the northerly side from a point distant 250 feet westerly from the intersection of Cedar Street for a distance of 50 feet.
 - (3) On the southerly side from a point distant 315 feet westerly from the intersection of Walnut Street for a distance of 185 feet.
 - (4) On the northerly side, westerly from the intersection of Walnut Street for a distance of 165 feet.
- I. South Avenue.
- (1) On the northerly side, westerly from the intersection of Center Street for a distance of 500 feet. [Amended 7-14-2022 by Ord. No. 22-09]

- (2) On the northerly side, from a point distant 700 feet westerly from the intersection of Center Street for a distance of 85 feet. [Amended 7-14-2022 by Ord. No. 22-09]
- ~~(3) On the southerly side from Center Street to West Street. [Amended 7-14-2022 by Ord. No. 22-09; 7-27-2023 by Ord. No. 23-19]~~
- ~~(a) Firefighter parking is permitted for a distance of 265 feet at a point 50 feet from easterly curb line of West Street. Parking is only permitted by firefighters responding to an emergency call.~~
- (43) North side from the easterly curblines of Center Street a distance of 1,600 feet. [Amended 12-28-1999 by Ord. No. 99-22]
- ~~(54) North side between the Borough of Garwood-Township of Cranford corporate line and New Street.~~
- ~~(65) On the southerly side from the westerly curblines of East Street to a point 400 feet west thereof. [Amended 9-12-2019 by Ord. No. 19-17]~~
- ~~(76) On the southerly side from the westerly curblines of Maple Street to a point 80 feet west thereof.~~
- ~~(87) On the southerly side from the westerly curblines of West Street to a point 110 feet west thereof.~~
- ~~(98) (Reserved)~~
- ~~(109) On the northerly side from the westerly curblines of West Street to a point 136 feet west thereof.~~
- ~~(110) On the southerly side from the easterly curblines of Maple Street to a point 80 feet east thereof.~~
- ~~(121) On the northerly side from a point distance of 150 feet easterly of Maple Street for a distance of 95 feet east thereof.~~
- ~~(132) On the southerly side from the easterly curblines of Center Street to a point 60 feet east thereof.~~
- ~~(143) South side between a point 275 feet east of New Street and a point 340 feet easterly therefrom.~~
- ~~(1514) On the southerly side, easterly from the Town of Westfield line for a distance of 64 feet.~~

J. South Avenue - Garwood Mall.

- (1) No person shall park a vehicle and no stopping or standing of motor vehicles shall be permitted in the Shopping Center Complex located at 300 South Avenue, known as the Garwood Mall, on the paved roadway adjacent to the curb sidewalk fronting the stores, designated as fire zones by the Garwood Fire Department on the paved roadway of the rear of the stores nor in any area adjacent to the parking stalls. The provisions of Subtitle I of Title 39 of the New Jersey Statutes Annotated is hereby determined to be applicable and is adopted as a part of this chapter by reference.
- (2) Vehicles shall be parked in the Garwood Mall only in authorized parking areas and only within the painted parking stalls.
- (3) Parking shall be prohibited at all times in parking spaces set aside for the handicapped and which are so designated by signs or other markings, except by persons who have been issued Special Vehicle Identification Cards by the Division of Motor Vehicles pursuant to the provisions of N.J.S.A. 39:4-204, 39:4-205, 39:4-206,

39:4-207, Public Law 1981-C-1936 and Public Law 1983-C-1996 when using a motor vehicle on which is displayed a certificate for which a Special Vehicle Identification Card has been issued pursuant to said law.

(4) The site plan approval by the Planning Board of the Borough of Garwood is incorporated herein by reference.

K. South Avenue - Lidl Complex. [Amended 7-14-2022 by Ord. No. 22-09]

(1) No person shall park a vehicle on the premises of the Garwood Lidl Complex located at 3-10 South Avenue, Garwood, New Jersey, on the paved roadway adjacent to curbed sidewalks fronting the premises, the sideline in the rear of the premises nor in any area adjacent to the parking stalls.

(2) Vehicles shall be parked in the Garwood Lidl Complex only in authorized parking areas and only within the painted parking stalls.

(3) Parking shall be prohibited at all times in the parking spaces set aside for the handicapped and which are so designated by signs or other markings, as shown on the attached site plan which will be made a part of this chapter, except by persons who have been issued Special Vehicle Identification Cards by the Division of Motor Vehicles pursuant to the provisions of N.J.S.A. 39:4-204, 39:4-205, 39:4-206, 39:4-207, Public Law 1981-C-1936 and Public Law 1983-C-1996 when using a motor vehicle on which is displayed a certificate for which a Special Vehicle Identification Card has been issued pursuant to said law.

(4) Parking shall be prohibited at all times in those areas designated by signs and yellow paint as fire lanes.

L. Spruce Avenue.

(1) On the northerly side from the easterly curblineline of West Street to a point 60 feet east thereof.

(2) On the southerly side from the westerly curblineline of West Street to a point of 60 feet thereof.

(3) On the northerly side from the westerly curblineline of West Street to a point 60 feet west thereof.

(4) On the southerly side from the easterly curblineline of West Street to a point 60 feet east thereof.

(5) On the southerly side from a point distant 264 feet easterly from the intersection of Center Street for a distance of 58 feet.

M. Third Avenue.

(1) On the northerly side from a point distant 390 feet easterly from the intersection of Oak Street for a distance of 55 feet.

N. Walnut Street. [Amended 11-27-2001 by Ord. No. 01-20]

(1) On the easterly side, from the northerly curblineline of North Avenue to a point 87 feet north thereof, from a point 20 feet north thereof to a point 88 feet nine inches north thereof, and from a point 83 feet north thereof to the southerly curblineline of Second Avenue. [Amended 1-27-2009 by Ord. No. 09-02]

(2) On the easterly side, from the southerly curblineline of Third Avenue, southerly for a distance of 50 feet.

(3) On the westerly side, from the southerly curblineline of Third Avenue, southerly for a distance of 50 feet.

(4) On the westerly side, from the southerly curblineline of Second Avenue, southerly to North Avenue.

O. West Street.

(1) On the easterly side between South Avenue and Willow Avenue.

P. Cedar Street. [Added 11-27-2001 by Ord. No. 01-20; amended 5-11-2022 by Ord. No. 22-04]

(1) On the easterly side, extending south from the intersection of Third Avenue for a distance of 50 feet.

(2) On the northerly side from the easterly curblineline of Cedar Street to a point 50 feet east thereof

(3) On the southerly side from the westerly curblineline of Cedar Street to a point of 50 feet thereof.

(4) On the northerly side from the westerly curblineline of Cedar Street to a point 50 feet west thereof.

(5) On the southerly side from the easterly curblineline of Cedar Street to a point 50 feet east thereof.

Q. Chestnut Street. [Added 3-12-2002 by Ord. No. 02-07; amended 3-25-2008 by Ord. No. 08-06]

(1) On the easterly side, from the northerly curblineline of North Avenue to a point 50 feet north thereof.

(2) On the westerly side, from the northerly curblineline of North Avenue to a point 75 feet north thereof.

(3) On both sides between North Avenue and Second Avenue, for a distance of 20 feet on both sides of all driveways.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
