**AN ORDINANCE AMENDING THE BOROUGH CODE OF THE BOROUGH OF GARWOOD BY AMENDING CHAPTER 21, SECTION 8.7, ENTITLED "ON-STREET BUSINESS AND BOROUGH EMPLOYEE PERMIT PARKING."**

**WHEREAS**, the Borough of Garwood (the "Borough") has previously adopted Chapter 21 of the Code of the Borough of Garwood which established and governs restrictions and regulations on parking and traffic in the Borough; and

**WHEREAS**, the Borough is seeking to amend Section 21-8.7 "On-street business and Borough employee permit parking," and

**WHEREAS**, the Borough Council has determined it appropriate to amend said Code;

**NOW, THEREFORE, BE IT ORDAINED** by the governing body of the Borough of Garwood that Chapter 21 of the Borough Code of the Borough of Garwood entitled, "On-street business and Borough employee permit parking," section 8.7, is hereby amended as follows (additions underscored, deletions struck-through):

**A. Central Business District.**

- (1) Willow Avenue: the first two parking stalls on the north side of street heading west from Center Street.
- (2) Willow Avenue: the first five parking stalls on the south side of street heading west from Center Street.
- (3) Willow Avenue: the first two parking stalls on the north side of street heading east from Center Street.
- (4) Willow Avenue: the first four parking stalls on the north side of street heading east from Center Street.

**B. Willow Avenue.**

- (1) From a point 205 feet east of the southeast corner of the intersection of Willow and New Street for a distance of 170 feet.
- (2) Employee parking only.

**C. John F. Kennedy Plaza.**

- (1) Three (3) spaces as designated by the Chief of Police by appropriate signage.

**D. Parking in these locations is restricted to permit holders only, Monday through Saturday, 8:00 a.m. 6:00 p.m.**

**E. Permits.**


- (1) Permits are provided at no cost to Borough of Garwood employees.
- (2) Central Business District and John F. Kennedy Plaza adjacent businesses may purchase parking permits.
  - (a) \$60 per month.
  - (b) \$175 per quarter.
  - (c) \$325 per half year.
  - (d) \$600 per year.
- (3) All permits are assigned to a specific parking stall.
- (4) Permits are sold through the Municipal Clerk's office.

**BE IT FURTHER ORDAINED**, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

**BE IT FURTHER ORDAINED**, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
