ORDINANCE NO. 25-10

**AN ORDINANCE OF THE BOROUGH CODE OF THE BOROUGH OF
GARWOOD BY AMENDING CHAPTER 21, ENTITLED "VEHICLES AND
TRAFFIC", ARTICLE VII "PROHIBITED TURNING MOVEMENTS",
SECTION 21-16.4 "LEFT TURNS PROHIBITED".**

WHEREAS, the Borough of Garwood (the "Borough") previously adopted Chapter 21 of the Code of the Borough of Garwood which established and governs restrictions and regulations on parking and traffic in the Borough; and

WHEREAS, the Borough is seeking to amend Section 21-16.4 "Left Turns Prohibited" by referencing left turn prohibitions by addresses and remove names of businesses; and

WHEREAS, the Borough Council has determined it appropriate to amend said Ordinances; and

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Garwood that Chapter 21 of the Borough Code of the Borough of Garwood entitled, "Vehicles and Traffic", Article VII "Prohibited Turning Movements", Section 21-16.4 "Left Turns Prohibited" is hereby amended as follows (additions underscored, deletions ~~struck through~~):

No person shall make a left turn at the following locations:

- A. South from ~~McDonald's~~ the driveway located at (214-216 North Avenue) to east on North Avenue/Route 28.
- B. South from ~~Quick-Chek's~~ the driveway located at (252 North Avenue) to east on North Avenue/Route 28.
- C. North from ~~Burger King's~~ the driveway located at (~~225~~ 251 North Avenue) to west on North Avenue/Route 28.
- D. North from the center driveway at Garwood Plaza (301 North Avenue) to west on North Avenue/Route 28. **[Added 4-10-2007 by Ord. No. 07-12]**
- E. North from the westerly driveway at Garwood Plaza (301 North Avenue) to west on North Avenue/Route 28. **[Added 4-10-2007 by Ord. No. 07-12]**

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
