ORDINANCE NO. 25-12

**AN ORDINANCE AMENDING THE BOROUGH CODE OF THE
BOROUGH OF GARWOOD BY AMENDING CHAPTER 134, ENTITLED
“SEWERS”, ARTICLE V, “INDUSTRIAL WASTE AND FEES”,
SUBSECTION 134-15C**

WHEREAS, the Borough of Garwood has previously adopted Chapter 134, Subsection 134-15C which sets the rate for industrial user charges; and

WHEREAS, the Borough Council seeks to amend the Code to set a new rate; and

NOW, THEREFORE BE IT ORDAINED by the governing body of the Borough of Garwood that Chapter 134 (Sewers), Article V (Industrial Waste and Fees), 134-15C (Industrial Sewer Charge) of the Borough Code is hereby amended as follows (additions underlined, deletions ~~struck through~~):

§134-15C Industrial sewer charge.

C. Payment for industrial waste shall be based upon industrial waste flow.

1. The rate schedule for the industrial user charge shall be as follows:

Flow: Per million gallons \$5,357.06 ~~\$5,112.81~~

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final passage and publication in accordance with applicable law.
