**ORDINANCE NO. 26-01**

**AN ORDINANCE TO ESTABLISH A RESTRICTED PARKING ZONE PURSUANT TO N.J.S.A. 39:4-197.6 APPROXIMATELY 35 FEET NORTH OF THE CORNER OF NORTH AVENUE ADJACENT TO 260 NORTH AVENUE IN THE BOROUGH OF GARWOOD**

**WHEREAS**, N.J.S.A. 39:4-197.6 permits a municipality to establish a restricted parking zone in front of a residence occupied by a handicapped person; and

**WHEREAS**, the Mayor and Council of the Borough of Garwood has received a request from Michael Barakat of 260 North Avenue, Garwood, New Jersey, 07027, that a restricted parking zone be established in front of his residence; and

**WHEREAS**, the resident qualifies for the establishment of such restricted parking zone by virtue of having been issued a windshield placard or wheelchair symbol license plate by the New Jersey Division of Motor Vehicles; and

**WHEREAS**, the Mayor and Council find that parking is not otherwise prohibited and that the permitting of the establishment of a restricted parking zone would not interfere with the normal flow of traffic;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Garwood:

**SECTION 1.** A restricted parking zone pursuant to N.J.S.A. 39:4-197.6 is hereby established approximately 35 feet north of the corner of North Avenue adjacent to premises located at 260 North Avenue, Garwood, New Jersey, 07027, the residence of Michael Barakat.

**SECTION 2.** The posting of an appropriate sign by or at the direction of the Chief of Police is hereby authorized and directed.

**SECTION 3.** This ordinance shall be effective for so long as Michael Barakat shall continue to reside in the premises and shall continue to be eligible for the restricted parking zone established herein under N.J.S.A. 39:4-197.6.

**SECTION 4.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**BE IT FURTHER ORDAINED**, that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall
